Short-term gains may feel good, but long-term growth feels right.

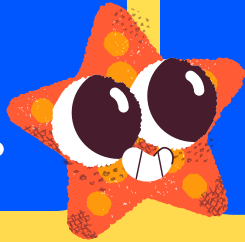

Negotiation isn't just for boardrooms or business deals — as a CA student, you're already negotiating more than you realize: timelines with your senior, workloads with your team, or fees with clients during articleship. Mastering the art of negotiation means learning how to get to a win-win outcome — one that benefits both sides without conflict.

Situation

Situation:

Your team is working on a tight audit assignment. The client insists the report be finalized in 3 days ahead of the deadline.



Problem:

Audit is progressing as per schedule and will be delivered on time. Earlier delivery will not be possible.



Approach:

- Step 1: Talk to the client respectfully: "We want to deliver a high-quality report. To ensure accuracy, can we split delivery – initial findings 3 days ahead and the final report as scheduled?"
- Step 2: Provide reasons – explain that rushing could compromise accuracy and lead to compliance risks.
- Step 3: Offer support – "We'll keep communication open and update you at every stage."



How to get better at it?

Prepare in Advance: Know your facts and desired outcomes.

Listen Actively: Understand the other party's needs.

Stay Calm and Respectful: Never let emotions take over.

Be Clear on Your Non Negotiables: Know what you can and can't compromise on.

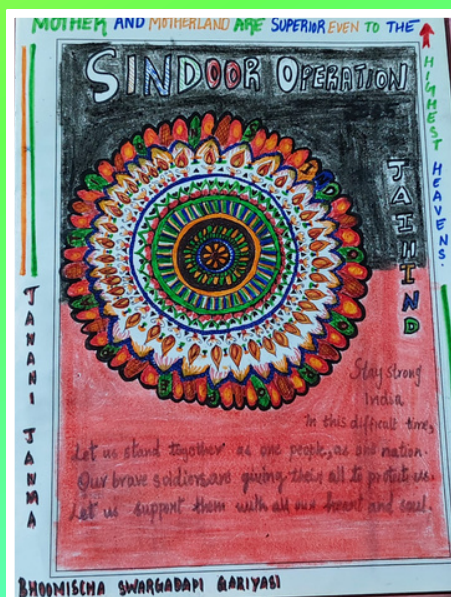
Aim for a Win-Win : Make the solution work for both sides.

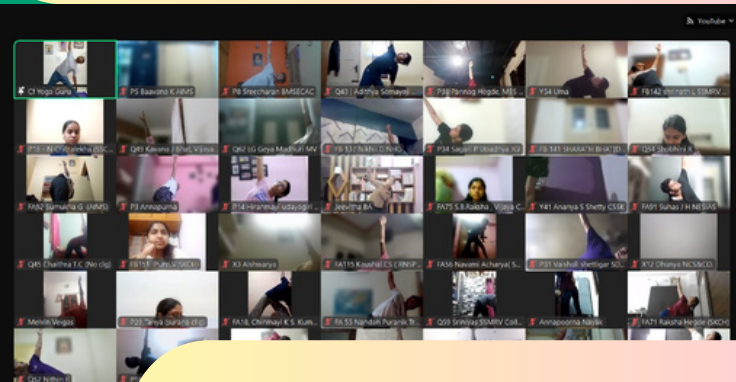
